Minutes of the meeting of Stackpole and Castlemartin Community Council held at Bosherston Church Hall on Monday, January 10th 2022, at 7.30pm.

Update on current issues

1. **Stackpole VC School-** The item relating to Stackpole VC School will be discussed at the next services meeting. There was no further update at the time of the meeting.
2. **St. Twynells Bus Shelter –** The bus shelter has been repaired however the council is still awaiting feedback from Helen McLeod-Baikie as to the whether the bus shelter can be passed to the community council on a peppercorn rent. At the time of the meeting there was no further update.
3. **Pot Hole Cheriton –** Due to the pot hole depth, not exceeding 25mm Pembrokeshire County Council stated it does not warrant a temporary repair. The matter is being passed to the Highway Asset Management Team for consideration if a permanent repair is required. At the time of the meeting the pot hole remains unrepaired.
4. **Visually Assisted Sign –** The matter was discussed at length; the council is exploring grant funding options to facilitate the purchase and installation of VAS signage.
5. **The Pound Castlemartin –** The sign is currently being refurbished, once this is completed Councillor Alderman will arrange to reinstate the sign in the pound. At the time of the meeting there was no further update on the sign.
6. **Parking Freshwater West, Bosherston, Stackpole Quay –** Councillor Alderman is going to arrange a multi-agency meeting with Pembrokeshire County Council, The National Trust and The Police to discuss the parking issues in Stackpole Quay, Bosherston and Freshwater West. At the tie of the meeting there has no date been set for the proposed meeting.
7. **Stackpole Church Hall -** The current position is the church are having a report drawn up to detail the specification of works required on the church hall which will be put out to tender. At the time of the meeting there was no further update at the time of the meeting.
8. **Stackpole Cheriton Slow Sign -** The councillors asked the clerk to contact Darren Thomas of Pembrokeshire County Council and request a slow sign for Stackpole Cheriton. At the time of the meeting there was no further update at the time of the meeting.
9. **Notice Board Stackpole –** Councillor Haydn Garlick will reinstate the noticeboard in the current location outside the former Stackpole VC School.
10. **Deer Park View -** The councillors have received numerous complaints in relation to business vehicles being parked in Deer Park View. The matter has now been referred to trading standards at Pembrokeshire County Council. There was no further update at the time of the meeting.
11. **Oil Leak Jason's Corner -** The last update is that each property is to have their own tank. The council properties being funded via Pembrokeshire County Council and the private

properties self-funding the cost of the new tank. At the time of the meeting there was no further update.

- 12. Jason's Corner Pot Hole** – A new pothole has developed at Jason's Corner the councillors asked the clerk to report it to Pembrokeshire County Council. At the time of the meeting the pot hole remains unrepaired.
- 13. Axton Hill Deep Drain** – The councillors asked the clerk to report the deep drain on Axton Hill to Pembrokeshire County Council highways department as car wheels could be damaged. The clerk has telephoned Pembrokeshire County Council and reported the drain.
- 14. Thorn Chapel sign** – The councillors asked the clerk to make enquires with Pembrokeshire County Council in relation to having improved signage in relation to excessive traffic looking for the Green Bridge of Wales up Thorne Chapel Road. A new sign has been erected, residents are requesting another sign further back and also requesting a sign to say when the army is firing that stack rocks is also closed. The councillors asked the clerk to email Castlemartin Camp to requested stack rocks is closed sign when army are firing. The councillors also asked the clerk to request a sign at Merrion to say stack rocks is closed and a directional sign to the green bridge of Wales at Merrion. At the time of the meeting there was no further update on the matter.
- 15. Clerk CILCA Course** – The clerk has submitted the complete Level One assignment for assessment and is now working through Level Two assignments.
- 16. Passing places Bosherton, Freshwater East and Valast Hill** - There are passing places from Valast Hill to St. Petrox however the passing places at Stackpole Quay need to be dug out. Councillor Alderman will arrange to speak Steve Benger of Pembrokeshire County Council to discuss the matter. There was nothing further to report at the time of the meeting.
- 17. Bosherton Street Lighting** – At the time of the meeting three lights remain unrepaired. The clerk has again telephoned Pembrokeshire County Council to request that the street light next to the community hall, the street light outside Windsor House and the street light outside Thornston be repaired.
- 18. Team Cleric** - Josh's has now left the Church in Wales and it may be some six month before a new vicar is recruited.
- 19. Chapel Hill Slow Sign** - The Community Councillors asked the clerk to request a slow sign at both entrance and exit of Chapel Hill going down and back up. Shangri La care home take residents out for a walk and to many cars going to fast becoming a hazard. There was no further update to report at the time of the meeting.
- 20. Speeding in Castlemartin** – The councillors are exploring funding options to facilitate the possibility of purchase and installation of VAS signage.
- 21. Road drop at Café Mor** – There is a serious road drop at café Mor in Freshwater West the clerk has reported the matter to Pembrokeshire County Council but at the time of the meeting there was no further update on the matter.
- 22. Broadhaven South** – The clerk has reported the missing plastic reflectors to Pembrokeshire County Council.
- 23. Bosherton Speed limit** – The councillors asked the clerk to contact Pembrokeshire County Council and request a 30mph from the church bungalow to the village.

- 24. Warren Cross sign** – The sign at Warren Cross to St. Twynnels is missing the councillors asked the clerk chase the matter up with Pembrokeshire County Council. At the time of the meeting the sign remains missing.
- 25. St. Twynnels Speed Limit sign** – Email received from Claire Williams requesting an indication of the area of concern so the monitoring equipment can be placed in the appropriate location.
- 26. Playground funding equipment and insurance** – It was discussed that an application could be made to the National Lottery to purchase and install new play equipment in Castlemartin and a service level agreement is in process with Pembrokeshire County Council. There was no further update at the time of the meeting.
- 27. Village Development Plan** – A meeting was held for Councillors David Edwards and Steve Alderman to meet with Mr and Mrs Arnold to discuss the local development plan.
- 28. Village Grit boxes** – The village grit boxes will be checked and replenished as necessary for the forthcoming winter.
- 29. Bosherton No Coaches Sign** - The councillors asked the clerk to contact Pembrokeshire County Council to ask for a no coaches or no vehicles over a specified length sign on the road from Bosherton village towards Broadhaven South to be placed on the existing narrow road sign.
- 30. White Salt like substance fly tipped at Freshwater West** - There has been a large amount of a white salt like substance fly tipped on the hill at Freshwater West leading towards Angle from Castlemartin. The councillors asked the clerk to report the fly tipping to Pembrokeshire County Council.
- 31. Speed Checks** - The councillors asked the clerk to arrange speed checks with the traffic department of Pembrokeshire County Council for Stackpole, St. Twynnels and Castlemartin.
