



Minutes– Angle Community Council Meeting @18.30, Wed 2nd March 2022

Angle Village Hall

1. Approval of minutes from meeting held 5th January 2022

2. Agenda items

1. Action points from last meeting.
 1. Housing review, Cllr Ward has tried to glean information concerning empty PCC properties, but this is not forthcoming.
 2. Hunt- Master of Hunt had contacted the Chair to apologise for the lack of information. Although a second had been planned it would not begin in the village, however it did not take place.
2. Councillor vacancy – No interest **but nomination packs now available for elections which need to be submitted by 16.00 on 5th April**, preferably before, to ensure accuracy without need to review which may prevent eligibility. **Action: Information regarding rules will be circulated as received from PCC.**
3. Playground update - all relevant forms completed by Cllrs Williams, Ward and Watkins. Payment of £400.00 to be made for the solicitor to proceed. Cllr Williams made contact with equipment provider on 28th Feb, with updated quote pending.
4. Queens Jubilee celebrations - Cllr Williams reported that a very successful couple of meetings have taken place, with a 4 day program planned. Together with many suggestions, a Samba band to join the procession on the 5th and provide some music for the picnic is one. In February, ACC agreed in principle to support some funding under S137. Cost of the Band is ~£250.00 which was supported by all
5. Coastal Erosion and Point Road. Cllrs Watkins and Williams met with Anthony Richards (PCNPA) on 14th February. He provided some background regarding maintenance of the road, and criteria for repairs of the gabions, which relates to the proximity of the erosion to the byway. For this reason, the section near the Old Point House is planned for the coming month (financial year 2021-2022) and the section near the Ridge is planned for Autumn (financial year 2022-2023). There was recognition of the deterioration of this section. Mr Richards also recognises the ongoing problems with maintenance of the road itself and is also monitoring the cracks in the bridge wall. **Action : Cllr Williams has informed the correspondent who raised concern**
6. OVW survey re Multi location meetings – due to lack of Wi Fi at the Village hall which we pay to use, we are currently unable to comply with Multi Location meeting regulations. After discussion it was agreed that we would approach the VH Committee to install Wi Fi and discuss an amicable agreement on a rent review. **Proposed: Cllr Watkins, Seconded Cllr Richards** **Action: Cllr Williams will approach VH Committee**
7. Clerk vacancy update – This has been advertised with no response
8. Update from County Councillor – Cllr Alderman informed us that the road between Llanbeath and Wallaston will be closed for 6 weeks for road widening, though dates unknown

- 2 **NP/22/0120/ Full re** Thorn island – Councillors have no concerns regarding the helepad or landing jetty, providing there are no deterrents/ obstructions to other vessels passing through the area of the waterway. There were however, concerns regarding the conference facility.
- 3 **DNS/3261355** – RWF update Cllr Williams did contact a member of the planning committee and was directed to another member of PCC, but has received no response. Cllr Alderman urged to raise this with the Council's Cabinet member for planning.
- 4 **DNS/3251528 – Erebus application** Arrived too late to Agenda, but responses required by 1st April- BEFORE the next ACC meeting
