Minutes of the meeting of Stackpole and Castlemartin Community Council held at Bosherston Church Hall on Monday, April 11th 2022, at 7.30pm.

Update on current issues

1. **Stackpole VC School-** The item relating to Stackpole VC School will be discussed at the next services meeting which is scheduled for next week.
2. **St. Twynells Bus Shelter –** The council is still awaiting feedback from Helen McLeod-Baikie as to the whether the bus shelter can be passed to the community council on a peppercorn rent. There was no further update at the time of the meeting.
3. **Parking Freshwater West, Bosherston, Stackpole Quay –** The councillors asked the clerk to contact Mark Owen of Pembrokeshire County Council and Jonathan Hughes Tegrin Jones of the National Park to arrange a joint meeting in May 22 to discuss the parking issues.
4. **Stackpole Church Hall –** There will be a meeting in approximately a fortnights time and the vestry are advertising for a new vicar at the end of April 22.
5. **Notice Board Stackpole –** Councillor Haydn Garlick will reinstate the noticeboard in the current location outside the former Stackpole VC School. This will be completed as soon as possible.
6. **Jason's Corner Pot Hole –** Temporary repairs have been carried out to the pot hole.
7. **Axton Hill Deep Drain –** The beat gang have checked the drain and cannot see any issues.
8. **Thorn Chapel sign –** The councillors asked the clerk to make enquires with Pembrokeshire County Council in relation to having improved signage in relation to excessive traffic looking for the Green Bridge of Wales up Thorne Chapel Road. A new sign has been erected, residents are requesting another sign further back and also requesting a sign to say when the army is firing that stack rocks is also closed. Councillor Alderman has spoken to Steve Harries of Castlemartin Army Camp and requested a sign stating firing occurring no access to the Green Bridge of Wales. There was no further update at the time of the meeting.
9. **Clerk CILCA Course –** The clerk is working through Level Two assignments.
10. **Passing places Bosherston, Freshwater East and Valast Hill -** There are passing places from Valast Hill to St. Petrox however the passing places at Stackpole Quay need to be dug out. This discussion will be incorporated with point 3 when the meeting is arranged.
11. **Bosherston Street Lighting –** At the time of the meeting the light outside Windsor House remains unrepaired as there is an issue with the electrics within the post. The councillors asked the clerk to request an additional street light between the Church Hall and St Govans

Inn. Currently the following criteria are evaluated irrespective of the rural or urban nature of an area:

1. Number of recorded night-time personal injury accidents
2. High vehicular traffic or pedestrian use
3. Levels of night-time crime
4. Number of residents of properties fronting the road or street

Application of this data enables the Authority to target expenditure on new street lighting installations to the areas where residents and road-users will derive the greatest benefit. Therefore, at present I regret to inform you that your location does not meet this criterion.

- 12. Chapel Hill Slow Sign** - The Community Councillors asked the clerk to request a slow sign at both entrance and exit of Chapel Hill going down and back up. The request has now been passed to Mel Evans of Pembrokeshire County Council. There was no further update at the time of the meeting.
- 13. Road drop at Café Mor** – There is a serious road drop at café Mor in Freshwater West the clerk has reported the matter to Pembrokeshire County Council. At the time of the meeting there was no further update.
- 14. Broadhaven South** – The clerk has reported the missing plastic reflectors to Pembrokeshire County Council. New bollards have been arranged to be installed.
- 15. Bosherton Speed limit** – The councillors asked the clerk to contact Pembrokeshire County Council and request a 30mph from the church bungalow to the village. Councillor Alderman is to arrange a meeting with Darren Thomas of Pembrokeshire County Council. Claire Williams of Pembrokeshire County Council has requested a map of the area the speed checks are required in Bosherton and Stackpole.
- 16. Warren Cross sign** – The sign at Warren Cross to St. Twynnels is missing the councillors asked the clerk chase the matter up with Pembrokeshire County Council. The matter has now been passed to Emrys Llewelyn of PCC who has ordered a new direction sign to St. Twynnels.
- 17. St. Twynnels Speed Limit sign** – Email received from Claire Williams requesting an indication of the area of concern so the monitoring equipment can be placed in the appropriate location. Claire is in the process of organising the monitoring equipment along with the equipment for Stackpole and Bosherton.
- 18. Playground funding equipment and insurance** – It was discussed that an application could be made to the National Lottery to purchase and install new play equipment in Castlemartin and a service level agreement is in process with Pembrokeshire County Council.
- 19. Bosherton No Coaches Sign** - The councillors asked the clerk to contact Pembrokeshire County Council to ask for a no coaches or no vehicles over a specified length sign on the road from Bosherton village towards Broadhaven South to be placed on the existing narrow road sign. The clerk has put in a request for the signage. At the time of the meeting there was no further update.
- 20. White Salt like substance fly tipped at Freshwater West** - There has been a large amount of a white salt like substance fly tipped on the hill at Freshwater West leading towards Angle from Castlemartin. Councillor Alderman will arrange to remove the substance. At the time of the meeting there was no further update.

21. Yurt and Pod regulations – The National Park temporary dwelling rules apply.

22. Land from Bosherton Quarry to Creature – the hedge requires cutting back. The hedge will be cut back by Pembrokeshire County Council.

23. Internet – Fibre broadband has been connected and will shortly go live in Stackpole.
