Cllrs reported that the Planning Portal could not be accessed, this has happened on a number of occasions. Cllr Lockley proposed that Kilgetty Begelly Community Council would not give a comment on this application, the Clerk to write to the Planning department and request the application be deferred until documentation is visible for Cllrs to make comment.
