- a. Marilyn Lewis reported potholes outside the Vicarage in Wiston.
- b. Yvette Bevan – (i) Reminded the meeting of the protest arranged for the Hospital at the Senedd in Cardiff on the 4<sup>th</sup> March. She also expressed her disappointment in the lack of support for County Councillors at previous protests in Cardiff, David Howlett confirmed that he would be attending as he felt it was an important issue for his ward. (ii) Concerns regarding the consultation process for the removing of 6<sup>th</sup> form education within Secondary Schools in the North of the county. (iii) Parking Charges in around St Thomas Green including Riflemans Field – does this area actually belong to Pembrokeshire County Council to enable them to action such charges? A petition will be placed in the shop in Clarbeston Road objecting to the implementation of parking fees. (iv) Dog fouling is still a problem on the lane along the railway line, dog owners are still bagging up their dog's mess but leaving the bag at the entrance of the lane.
- c. Phil Davies had nothing to report.
- d. Robert Voyle was pleasantly surprised that work had begun, at Cuckhold, on widening the road. Rotary clearing of the ditches had been actioned of a fashion, however it did not feel what had been actioned would solve issues in the Clarbeston area. Would it be possible to place a bollard on approaching Stepside Bridge from Clarbeston Road? Robert had spoken to Eira Griffiths who confirmed that she would be standing down as a community councillor for the Wiston Ward. The clerk would now get in touch with Alan Vaughan and Rhys James to invite them to take up the vacancies on the council. If they agreed this would mean that Wiston now had a full complement of councillors for the ward.
- e. David Howlett had nothing further to report.
- f. Rosemary Richards reported the bad state of repair of the road at Colby Corner, David believed that this had been repaired. However councillors believed that patching the damage was not sufficient and the road needed resurfacing.
- g. Peter Lewis – reported a hole by the grating at Lowerhill Wiston, which would need repairing.
