2346 Pavilion Vandalism

Another window has been broken at the pavilion. Cllr N James outlined what was known about the incident. Cllr M Fielding reported that Halsted has fitted laminated glass to avoid future breakage. Councillors discussed how to avoid future incidents as this is the third window to be broken in recent times. Cllr N James reported damage to a bench and hazardous broken bottles – will repair and make safe.

- 2348d** Cllr N James raised the fact that Upper Nash do not have a defibrillator. Suggested a fundraising campaign to purchase one. Cllr James will approach Valero to ask if they can help.
- 2348e** Cllr B James noted that signage has been removed from the Eastern Croft Lane to Nash Farm footpath. Raise with PCC.
