## b.. AUDIT OF ACCOUNTS 2017.18

The Clerk reported that the Audit had now been completed. The Auditor had drawn attention to the following matters in it's 'Report'.

#### *i. Notice of Appointment of Date for the Exercise of Electors Rights.*

This had commenced prior to the date Council approved the accounting statements.

In future years the Council must ensure that the Annual Return is approved before the Notice period commences.

Additionally, the Notice only allowed 19days for inspection and not the 20days stipulated.

It was agreed to ensure that the Council is in compliance in the future.

### ii. <u>High Level of 'Reserves'</u>

The level of general reserves was approx. 1.9 times that of the annual precept.

The Clerk/RFO reminded Council that 'earmarked' reserves were held but there is no provision or requirement for these to be shown in the Annual Return to Audit.

It was agreed that Council continue to monitor general reserves to ensure that non-earmarked levels are kept at an acceptable level.

i. Play Area Re-development.

AL reported that the new equipment was in the process of being installed and was scheduled for completion this week.

ii. Community Garden changes.

The bed has been cleared and is being prepared for re-planting in the Autumn. Trees moved from the play area to allow space for the new zip-wire, have been relocated to this bed.

#### a. <u>British Legion – Spittal Branch[DL]</u>

It was reported that the Spittal Branch would remain at the present time. The Branch will carry out it's role this year in selling poppies. Flag will not now be 'laid up' following this year's 'Remembrance Day Services'. [see also min:16.18.b].

#### b. Footpaths - Boot&Shoe to Dingle Lane; Boot&Shoe To Elm Park.[AD]-

It was reported that the PCC are carrying out a feasibility study into the provision of these footpaths to link the Community with the existing path from the Boot&Shoe to the Cardigan Road roundabout.

#### c. <u>Dingle Lane – Sewer Overflows[RM]</u>

It was reported that there had been a number of incidents at the manhole near to Dingle Farm as the result of high rainfalls. On each occasion Welsh |Water has attended. The possibility of rain run-off from private properties directly into the drainage system is being investigated.

#### d. <u>Blackthorns, 16 Dingle Lane Crundale[17.1291.PA][</u>RM]

Work has commenced on this site.

Concern was expressed as to the felling of tree[s] and removal of hedgebank. The application indicated the retention of all hedges except that allowing the new entrance to the driveway.

### e. Vehicle incident]10.09.18]GB.

It was reported that an incident involving a vehicle damaging fencing at the entrance to the Community Hall, had occurred today.[10.09.18] The driver did not stop but the vehicle was later identified. The matter has been reported to the police. The Community Association have been advised.
