# 36.19 Minutes of Council Meeting held 8th July 2019

It was proposed by R.Moffat and seconded by D.Lloyd that the minutes be approved.

#### 37.19 Matters Arising

-20.19 Notice of Vacancy – To-date, there have been no applications for the current vacancies

-23.19ii PC Thomas – The clerk read out an email which she received from PC Thomas on 17<sup>th</sup> July. PC Thomas informed us that PSCO Naomi Hicks will now be covering our parish and in charge of the speedwatch equipment. It was identified that Crundale was not a designated area for regular speedwatch attendance, although PC Thomas had asked them to attend following our request. It had been identified, that in a 2 hour period, 8 motorists were caught exceeding the speed limit.

## 41.19 County Councillors Report

- i. Dog Fouling County Councillor informed us he had spoken to the complainant.
- ii. Speed data The speed data equipment had been installed and the information provided showed there have been cases of speeding, however, these were either early in the morning or late at night. It was felt that the mere presence of the equipment encouraged drivers to slow down.
- iii. Dingle Close According to the schedule that was sent, the contractor has now exceeded the time frame in which he promised to get things finished. A complaint had come in from one of the residents living in Dingle Close, via a Councillor, due to her child being injured as a result of the unfinished works and the dangerous site.

- iv. Withybush Woods Work is progressing. There will be an article in the Western Telegraph informing and inviting groups of people to a bulb and tree planting session.
- v. It has been noticed that a camera has been placed opposite the junction of Boot and Shoe Close. There is uncertainty as to the purpose of this camera, so SY will make some enquiries.
- vi. SY informed us, the cabinet had approved a joint venture between the food park and the welsh government.
