76.19 COUNTY COUNCILLORS REPORT.

1. Dingle Close – Work is progressing, with the following having been completed; street lighting testing, surface water drainage. Once the road has been adopted, it is hopeful that all will be completed by March.
2. Withybush Woods – Paths around the lower pond have been completed. A bulb planting session is hopefully planned for March.
3. Foot path-Rosemary close to Boot & Shoe Close-progress is being made and the Council are hoping to have works starting soon.

77.19 RUDBAXTON COMMUNITY ASSOCIATION.

SVD reported that they were planning a tree planting session.

GE reported that the RCA have decided on which chairs to purchase, to replace the damaged ones. The cost for these chairs will be £3638 and the question was asked if the Community Council would be willing to contribute towards this cost. It was agreed that the item would be on the agenda for full discussion at the next meeting.

A litter picking session has been decided on as the previous one, 2 years ago was very successful. They will meet on Sunday 19th April at 10am, possibly with refreshments afterwards at the hall.

The RCA are looking into improving the lighting in the carpark, with the possibility of solar lighting. Costs etc will be explored before any decision is made.

This year will see the 25th Anniversary of the hall being built. The RCA are looking into holding a funday in August sometime. Further details to follow.
