We will also ask him whether it would be possible to maintain the verges around the area of Boot & Shoe close.
- c. AL brought up the condition of the roads between Crundale and Scolton, which falls under our parish, suggestions were brought up around the problems originating from from works undertaken by the utilities which had an impact on the road condition, leading to patching, and subsequent debate about responsibility for road surface repair.
