Minutes of the meeting of Stackpole and Castlemartin Community Council held at Castlemartin Community Hall on Monday, May 9th 2022, at 7.30pm.

**Update on current issues**

1. **Sustainable Freshwater west** – The councillors asked the clerk to arrange a date for them to meet with Stuart Berry of PLANED to discuss the sustainable Freshwater West project.
2. **Stackpole VC School**- The item relating to Stackpole VC School will be discussed at the next services meeting. There was no further update at the time of the meeting.
3. **St. Twynells Bus Shelter** –. The council is still awaiting feedback from Helen McLeod-Baikie as to the whether the bus shelter can be passed to the community council on a peppercorn rent. The councillors asked the clerk to contact Helen McLeod-Baikie for an update on the matter.
4. **Parking Freshwater West, Bosherton, Stackpole Quay** – The councillors asked the clerk to contact Mark Owen of Pembrokeshire County Council and Jonathan Hughes-Tegrin Jones of the National Park to arrange a joint meeting to discuss the parking issues. There was no further update at the time of the meeting.
5. **Stackpole Church Hall** – The vestry are advertising for a new vicar. At the time of the meeting there was no further update.
6. **Notice Board Stackpole** – Councillor Haydn Garlick will reinstate the noticeboard in the current location outside the former Stackpole VC School. There was no further update at the time of the meeting.
7. **Thorn Chapel sign** – The councillors asked the clerk to make enquires with Pembrokeshire County Council in relation to having improved signage in relation to excessive traffic looking for the Green Bridge of Wales up Thorne Chapel Road. A new sign has been erected, residents are requesting another sign further back and also requesting a sign to say when the army is firing that stack rocks is also closed. Councillor Alderman has spoken to Steve Harries of Castlemartin Army Camp and requested a sign stating firing occurring no access to the Green Bridge of Wales. Councillor Alderman has requested that Castlemartin Army camp install new signage to show when firing is occurring that the road will be closed.
8. **Clerk CILCA Course** – The clerk is working through Level Two assignments.
9. **Passing places Bosherton, Freshwater East and Valast Hill** - There are passing places from Valast Hill to St. Petrox however the passing places at Stackpole Quay need to be dug out. This discussion will be incorporated with point 3 when the meeting is arranged. At the time of the meeting there was no further update.
10. **Bosherton Street Lighting** – There is an issue with the post outside Windsor House therefore at the time of the meeting that light remains unrepaired.
11. **Chapel Hill Slow Sign** - The Community Councillors asked the clerk to request a slow sign at both entrance and exit of Chapel Hill going down and back up. The request has now been

passed to Mel Evans of Pembrokeshire County Council. There was no further update at the time of the meeting.

- 12. Road drop at Café Mor** – There is a serious road drop at café Mor in Freshwater West the clerk has reported the matter to Pembrokeshire County Council. At the time of the meeting the drop has not been repaired.
- 13. Bosherton Speed limit** – The councillors asked the clerk to contact Pembrokeshire County Council and request a 30mph from the church bungalow to the village. Claire Williams of Pembrokeshire County Council is organising the speed checks are required in Bosherton and Stackpole.
- 14. Warren Cross sign** – The sign at Warren Cross to St. Twynells is missing the councillors asked the clerk chase the matter up with Pembrokeshire County Council. The matter has now been passed to Emrys Llewelyn of PCC who has ordered a new direction sign to St. Twynells. The sign has yet to be replaced.
- 15. St. Twynells Speed Limit sign** – Claire Williams of Pembrokeshire County Council has organised monitoring equipment which has been completed in St. Twynells.
- 16. Playground funding equipment and insurance** – It was discussed that an application could be made to the National Lottery to purchase and install new play equipment in Castlemartin and a service level agreement is in process with Pembrokeshire County Council. The SLA is now in place with Pembrokeshire County Council.
- 17. Bosherton No Coaches Sign** - Rob Evans of Pembrokeshire County Council is Arranging for an unsuitable for coaches sign to be installed at the village end of the road to the beach.
- 18. White Salt like substance fly tipped at Freshwater West** - There has been a large amount of a white salt like substance fly tipped on the hill at Freshwater West leading towards Angle from Castlemartin. Councillor Alderman will arrange to have a sample tested and remove the substance.
- 19. Presence of elderly pedestrians** – The community Council councillors are considering funding for indicate presence of elderly pedestrians. Councillor Edward Morris is to enquire how much signs would cost.
