Update on current issues

- 1. John Allen-Mirehouse A minutes silence was held to mark the death of John Allen-Mirehouse.
- 2. Ye Olde Wordle Café In view of the number of complaints to the removal of clause 5 and 6 the councillors asked the clerk to request the decision goes to full planning committee to review the removal of the two conditions and not be delegated.
