## **NEW MOAT COMMUNITY COUNCIL**

**MINUTES** of the **COUNCIL MEETING** held of Wednesday, the 16th day of November 2022 at 20:00 in New Moat Church

MEMBERS PRESENT: Cllr H Warlow (Chair), Cllr D Howells, Cllr J Bushell, Cllr E Davies, Cllr M Himsworth, and S Harding (Clerk).

Others - Cllr D Howlett as Pembrokeshire County Council representative.

- 1. APOLOGIES FOR ABSENCE: NONE
- 2. DECLARATION OF KNOWN INTERESTS NONE
- 3. APPROVAL OF PREVIOUS MEETING MINUTES dated 31st August 2022 Decision Approved
- **4. Update on Notice Boards** The notice boards had been received and distributed . 1. The YFA had agreed to install the board at the front of their building, 2. The notice board in New Moat would be installed following renovation work being undertaken, 3. Penffordd notice board yet to be installed. **Decision Noted**
- 5. Update on Broadband Cllr Howlett and Sue had continued to have zoom calls with Broadway Broadband and Pembrokeshire County Council to discuss the installation project. The provider hoped to start connecting some properties in November with a completion by March 23. Cllr Howlett informed the group that BT was now offering full fibre in Llys-y-fran and some people had joined. Decision Sue to circulate a copy of the transcript of the meeting s and maps for information
- 6. PRECEPT 2023/2024- Decision As the Community Council still had a credit balance in the bank it was agreed to keep the amount the same as other years at £1000
- 7. Annual Community Meal Sue had received quotes ranging from £15 27.95(was 33.95 before discount) per person. Donations have been sort from Broadway Broadband, Velero and MHPA. Decision Agreed to hold the Community meal on the 7th January charging £5 per head. Sue to contact the caterer for numbers and circulate list. Previous Clerk to be invited as guest of honour
- 8. Second Home Premium/Enhancing Pembrokeshire Grants are available under 5 criteria 1. Raising overall standards of achievement, 2. Healthy Communities (appropriate housing/social care), 3. Increase productivity and address regeneration issues, 4. Safeguarding our environment, 5. Self sustained and vibrant communities. Sue gave examples of some projects which have received grants and noted that as New Moat area had not applied for any grants the annual figure of £1,400 had accumulated to £7,900 currently being available this year. Decision Sue to promote to local organisations such as the YFC and church's to highlight the grant process.
- Save Withybush Hospital Campaign Discussion took place on recent experiences of medical care in the area. Decision - adopt the model suggested by 'Save Withbush' on the Community Council Website
- 10. WAG Section 6 Biodiversity and Ecosystem resilience duty Sue explained that the Community Council is required to produce a report by the end of the year on actions taken to help maintain and enhance biodiversity. Discussion took place on the increased regulations and requirements on small Community Councils which are becoming onerous. Decision Sue to produce a basic report from examples given at the meeting.

- 11. Boundary Commission for Wales The changes are for national elections and are not affecting local elections so New Moat area will remain as part of Pembrokeshire Council. Decision Respond by 10/1/23 highlighting that we will potentially be dealing with two MP's one representative in Pembrokeshire and one in Caridigion and Preseli; concern that as New Moat will be on the lower boarder there will not be the same ease of local access to representatives. Most residents in the New Moat area undertake work and activities in the south of the proposed divisional boundary.
- 12. Independent Remuneration Panel for Wales The draft report suggests a maximum amount to be paid to Members being £156 (equivalent to £3 a week) and an additional amount for consumables £52 a year. Sue had received a questionnaire and members completed it during the meeting. Decision Members would not be taking any financial payment for being a Cllr as they did it voluntarily. Sue to complete the survey by 1/12/22
