Minutes of the monthly meeting held at Hen Ysgol Eglwyswrw on Tuesday 4th of April 2023 at 8pm

149. PRESENT

150. APOLOGIES

Cllr Ieuan Davies. It was further noted that the Clerk Mrs Helen Evans had resigned forthwith. Her immediate resignation was accepted by all present.

151. CHAIRMAN'S OPENING COMMENTS

The Chairman welcomed all to the meeting and extended sincere congratulations to Cllr Lon Davies on recently becoming a grandmother once again. PCSO Andy Marwick was welcomed to the meeting to present an overview on community policing issues. It was noted that the incident involving the discovery of hypodermic needles at the Church Yard had been investigated and a suspect had been identified. An unrelated matter of articles being found in the church yard which suggested a rough sleeper had also been dealt with. The individual involved had been identified and spoken to. Other more general policing matters were discussed including, speeding motorists through Eglwyswrw and the need for residents to make online representations to Go Safe, general illicit drug abuse and police presence within the community. PCSO Marwick was thanked for his presence and contribution and remained for the duration of the meeting.

152. Minutes of the monthly meeting held on the 7th March 2023

After pre circulation of the minutes and consideration of their accuracy, they were noted and signed as a correct record. It was a unanimous decision of all present.

153. Matters arising and update on Action Log

129. Replacement Clerk – The Vice - Chairman informed the meeting that only one candidate had applied in the name of Mrs Nia Siggins from Eglwyswrw. A CV was circulated to all and it was unanimously agreed to appoint Mrs Siggins in the hope she could commence employment at the beginning of the new Municipal Year in May or as soon as possible thereafter. The Clerk was instructed to write to her and invite her along to the next meeting when pay and conditions would be finalised. The Clerk was further instructed to draft a contract of employment for consideration by all parties. **Action – Clerk.**

131. Seek Internal Auditor - Chairman informed the meeting that retired chartered accountant Mr Adrian Charlton of Chestnut House had agreed to act as Internal Auditor. Clerk to make contact and arrange the internal audit review. **Action – Clerk.**

Matters for Decision

154. Community Council Draft Bio Diversity Report – The draft report was approved by all present.
155. VAT and Financial update – It was established that the last VAT Claim was made in November 2014. A claim would now be made for the last three years which was the maximum claim back period allowed. It was reported that VAT of circa £480 would be lost to the community, due to being out of time. Matters in relation to PAYE and last year's Audit was currently being looked into by the temporary Clerk. A further report would be presented in May. **Action – Clerk.**
156. Canolfan Llwynhirion - Notice Board – Cost £1,983.02p – *At the outset of consideration of this item Cllrs Arwel Evans and Lon Davies declared a personal interest in the matter as members of Canolfan Llwynhirion. Both left the room and did not participate in the item.* Donation request towards the costs of the new Notice Board at Llwynhirion was received. Before considering the matter further, it was decided to establish what was the net cost of the Notice Board after all grants received and whether a contribution had been received from Nevern CC. A copy of the recent accounts of Canolfan Llwynhirion was also to be requested as is now expected of all recipients of financial support from the Community Council.

165. Acc balance net of all payments = **£5,677.25p** as per circulated bank statement – was noted.

166. County Councillor's Report

- a. Fly tipping Trewilim area – It was agreed with the consent of the landowner to place a No Fly Tipping Sign at the location. Cllr Jones kindly offered to supply the sign free of charge. It was further noted that waste had been dumped on Feidr Las near Penclawdd Hir. It was noted that the waste would have to be removed by the landowner as it was deemed to be on private land. **Action – County Cllr Davies and Cllr Jones.**
- b. Speed Sensitive Sign B4332 – It was reported that an application was in the process of being made to WWHA for a financial contribution for a Speed Activated sign on the B4332 at Eglwyswrw. The cost of the unit under consideration was circa £4,000. To make it a viable application there would be an expectation on the Community making a financial contribution as well. It was resolved by all present to offer a £1,500 contribution as part of the application. **Action – County Cllr.**
- c. Road drain issue B4329 Tafarnbwlc, Brynberian – It was reported that Messrs Rees Penanty were concerned regrading the volume of water discharge into their field post road drains renewal some two years ago. County Cllr Davies had met the family on site and it was established that the

cattle grid drain was blocked allowing significant surcharging of water runoff into the new drains. Since the site visit the drain had been cleared and CCTV investigations had established that part of the highway drain near the cattle grid had collapsed. Highways department would now proceed to replace the collapsed drain, which should significantly reduce the volume of water entering Penanty farm land further down. – It was noted.

d. Brynberian Bio Diversity Group – County Cllr Davies informed the meeting he would be attending a meeting with the group on the 26th of April to discuss verge cutting by the highways department. Members wished to make it clear that it was the view of the Community Council that cutting all verges once a year was essential to maintain road safety.

Matters to be considered at the next meeting

167. Cllr Arwel Evans asked for the defibrillators batteries for all three defibrillators to be checked and batteries replaced if need be. **Action - Clerk and Cllr Evans.**

168. Cllr Jones raised the issue of the running costs of the Church floodlights and the need to replace one faulty unit. It was agreed to consider at the next meeting the option to control the floodlights on a time switch to reduce the running costs of the floodlights due to high energy costs. **Action - Clerk.**
