- Email received regarding the Pembrokeshire Lido Project to be located at Milford Haven.
- Email received requesting the Manorbier Community Council to consider if the local football club (to be reformed) could mark and use the football pitches on the Manorbier Community Council's owned land. The Clerk to advise that the Council approve this request.
- Telephone call received regarding the impassable conditions of the diverted public footpath in Jameston, due to construction works. The Clerk confirmed that she had spoken to the Public Rights of Way Officer advising of such and a response was awaited.
- Audit 2021/2022 The Clerk has contacted the Auditor General for Wales regarding the outstanding external audit. It is confirmed that the Audit Office still has not completed such. This is no reflection on the Manorbier Community Council but due to the workload of the officers.

#### 2023/01 128 To receive County Councillors Report

#### **Cllr Peter Kidney reported that:**

- The drains situate at Station Road have become blocked, this has been reported to Pembrokeshire County Council.
- A seminar regarding the Long Course weekend is due to be held discussions will be held relating to the logistics of the event.
- Pembrokeshire County Council has purchased Edwards Coaches to fulfil its legal obligations to provide bus transport to and from local schools.
- Manorbier Community Council will receive £1,000 from the organisers of the Long Course Weekend Manorbier has been named as the best supporting village along the route. In 2019 Manorbier was lucky to receive the same award this was used to purchase and site two benches overlooking Manorbier Bay.

## 2023/01 130 To consider the Manorbier Community Council's continued monetary support to Jameston Village Hall to ensure the hall remains in good repair.

The Manorbier Community Council were advised, by Jameston Village Hall Committee members, that Pembrokeshire County Council, at this point in time, are not paying towards the hire of the Jameston Village Hall nor have any formal contract/lease in place, therefore Jameston Village Hall Committee are having to pay all the ongoing bills without generating its usual income from room hire.

The Manorbier Community Council were also advised that it has been proven that there are no Covenants in place preventing Jameston Village Hall from providing a place of learning.

Cllrs Hughes and M Kidney left the meeting room.

Following a discussion Cllr Lane proposed that Manorbier Community Council offer a grant of £1,000 to Jameston Village Hall to enable the maintenance of a community learning space; Cllr Clarke seconded the proposal with all Cllrs in full support.
