## 2441 Approval of Minutes 10th October 2023

Minutes of the meeting were approved – Cllr G. Mills proposed; Cllr T. Wilson seconded.

#### 2442 Matters Arising

- 2442a (2432a) Following the meeting with Cosheston AFC a draft contract has been drawn up. Cllr T. Wilson proposed adding a clause to ensure the contract is reviewed annually Agreed. Discussion took place over the proposed charge to the football club of £1,300 for the season 2023/24. Approved on vote 4 in favour, 1 against.
- **2442b** (**2434a**) The Chair informed the meeting that Welsh Government will be providing traffic lights at the finger post junction in Summer 2024, and a 40mph speed limit will be introduced.
- **2442c (2434d)** Cllr N. Burgess gave an update on Woodfield woods. As there are ongoing issues between The National Park and the owners of the woods with regards to safety due to fallen trees it is likely that the woods will remain closed for another year. This has been confirmed by a National Park statement.
- **2442d (2434e)** Cllr N. James has installed a new gate and the line painting for the village hall car park will be done when the weather is drier.
- **2442e** (**2434f**) Cllr N. James has contacted the PCC's Neil McCarthy about the bin issue at the Pill and the football field. **Awaiting a response.**
- 2442f (2437a) The wreath has been ordered for Remembrance Sunday.
- **2442g (2437b)** Sue Richards has received the £370 to finance Cosh Callout for the remainder of 2023. The Council will discuss future grant funding at its next meeting.
- **2442h (2437d)** The Chair informed the meeting that following a meeting with Cosheston VC School the three trees donated by the Pembroke and Pembroke Dock Lions Club will be planted in the football field area by the children on 16<sup>th</sup> November at 2pm.
- 2442i (2437e) After further discussion regarding the purchase of two additional defibrillators it was agreed to put the purchase on hold due to the current financial position of the Council. It was agreed to look at The Enhancing Pembrokeshire grant to seek funding. Clir G. Mills to explore.
- **2442j (2437f)** A discussion took place regarding speed-activated reminder signs. Locations were discussed but no decisions were made.

- 2442k (2438a) The Chair informed the meeting there had been two applicants for the post of Temporary Clerk to the Council. One applicant stood out as having current experience in clerking at another Council and after discussion it was agreed to appoint that candidate. Chair to notify both candidates accordingly.

- 2442m (2438d) There was a discussion regarding parking around The Cross in the village. Cllr T. Hodgson would ask PCSOs to monitor around start and end of school in particular.
