Minutes of the meeting of Stackpole and Castlemartin Community Council held at St. Twynnells in Community Hall on Monday, February 5th 2024, at 7.30pm.

## **Update on current issues**

- **1.** National Trust Update Talk by Mark Underhill Countryside Manager Pembrokeshire National Trust.
- 2. Stackpole Church Hall Councillor Morris has spoken to the rural dean who has provided clarification that the church is paying for the contractor to demolish the church hall. The land that it is built on belongs to the dioceses. All of the items have been removed from the church hall and are being stored in a storage container.
- **3.** Clerk CILCA Course The clerk has submitted unit 3 and 5 and has 7 remaining assignments to complete.
- **4. Councillor Training** Councillor Clare Strudwick will attend Code of conduct training on the 8<sup>th</sup> February 2024 and Councillor Morris will attend the Local Government Finance training on the 21<sup>st</sup> February 2024.
- **5. Jason's corner heating** Work has commenced to install solar panels on properties 2 and 3 the village and number 8 Jason's Corner.
- **6. Bosherston Quarry** The quarry sign is on order and will be erected in the spring. There was no further update at the time of the meeting.
- **7.** Castlemartin Play Park Councillor Alderman to collect the apple trees on the 6<sup>th</sup> February and they will be set in the play park on the 6<sup>th</sup> February 2024.
- **8. St Twynnells 20mph Speed Signs** The signs have been positioned on the side of the grass verge fifteen foot apart and could easily be knocked by passing tractor or lorry.
