Peter James raised concerns about overhanging trees on the road from Wernlwyd farm to Welsh Hook and the condition of the Sealyham road due to the large volume of heavy farm machinery and goods vehicles using it

Bryn Harries mentioned the damage done to verges and ditches along the Sealyham crossroads to Welsh Hook road by large tractors and equipment with drivers pulling offroad to pass other vehicles, the roadway below Allt yr Afon had blocked drains

Brian John stated he had been asked by residents of Haul y Bryn road about the condition of trees on the hegebank from the Wolf Inn towards Hayscastle. Residents had also enquired about having suitable dropped kerbs on the footpath for wheelchair users and pedestrians as the road was always busy with heavy transport.

The clerk would contact highways regarding these matters

Members also raised concerns about ongoing issues with the sewrage problems in the village. The clerk would contact Dwr Cymru.

Chapel carpark hedge trimming, it was agreed by members to ask D Williams Chapel Farm if this work could be done.
