

St Florence Community Council

Minutes of the Community Council Meeting held at 7.30pm on Tuesday 4th September at 7.30pm, St Village Hall St Florence.

Present : Cllr Griffiths, Cllr Evans, Cllr Adams, Cllr Morgan, Cllr Treherne, Cllr Eardley and Cllr Buckmaster.

- 1. Public Participation (limited to 15 minutes) :** None
- 2. Minutes of the meeting held 7th August** The minutes of the previous meeting were reviewed and Cllr Morgan proposed them as an accurate record and Cllr Adams seconded, all the councillors were in favour.
- 3. Declarations of Interests.** Cllr Evans declared an interest in Invoices payable.
- 4. Matters Arising.** One space still remains on the council and two letters from interested parties were received. The clerk read both letters to the council and anonymous votes were cast, the clerk was asked to write to both parties with the outcome. The council look forward to welcoming Cllr Susan Phillips to the next meeting. A letter from the current person cutting the village verges was received. He wishes to end his contract so the clerk was asked to put a sign in the notice board inviting any interested parties to contact her regarding the contract. Councillors discussed land at the Old Cemetery being used to house chickens. The land belongs to the United Reform Church who will look into the matter. It was discussed that lockable storage in the garage for clubs who regularly hire the hall could be an option, with a charge to hire them. A quote was received from the caretaker to carry out such work and it was proposed by Cllr Evans and seconded by Cllr Adams to carry out the work, all councillors were in favour. A skip would be needed to clear rubbish in the garage, the clerk will look into this.
- 5. Finances.** The Bank Balances were read out by the clerk. Invoice payable were Clerks wages and expenses, Swalec, St Florence Cricket club and Michael Evans Landscapes. Payment was proposed by Cllr Eardley and seconded by Cllr Treherne all councillors were in favour.
- 6. Planning.** Application number 11/0765/PA Erection of 14 dwellings south of Longstone. Outline planning permission has been granted. Councillors discussed the fact planning had been granted even with numerous complaints.
- 7. Correspondence** was received from the Community Health council which Cllr Buckmaster will read over. Information in the form of a brochure on the proposed Civic Amenity site in New Hedges was looked at by the council.

The meeting closed at 8.10pm. The next meeting will be held on Tuesday 9th October 2012 at the village hall. Please note this is not the first Tuesday in the month as usual but the second.
