

MINUTES UZMASTON, BOULSTON AND SLEBECH COMMUNITY COUNCIL held in

3. Chairperson's Opening Remarks:

Mrs Campbell welcomed everyone to the meeting. The above apology was received and the minutes of the previous meeting were read, signed and accepted as accurate record.

4. Matters Arising :

a) **Precept** for 2013-14. An increase this year was requested to cover the cost of replacing the notice board on the main road and other items as needed.

b) **Boundary Commission** : It had been suggested that a boundary review and a possible merger for Uzmaston and Boulston County Council Wards to be merge with Rudbaxton, this would in principal mean that the Uzmaston/ Boulston and Slebech would have 2 separate County Councillors because Slebech would still remain under the Mart letwy Ward, and Uzmaston and Boulston would join with Rudbaxton. Proposals had been put forward by County Council and local MP's. This will not take effect until 2017 and is speculative at the moment.

c) **Planned** - Meeting had been held and a draft plan had been written up and circulated a further meeting to be held to discuss issues and review. The meeting had raised future projects which included Family History Project which is being led by Mrs Green, a Walking Group is being started and the newsletter. Parking is also going to be looked at; Cllr Lewis is going to meet up with Mrs Green. It was also reminded to mention that Woodleys where the gated area is should be regularly used to maintain the right of way.
