**2. Apologies for Absence:**

None received.

**3. Chairperson's Opening Remarks:**

Mrs Williams opened the meeting and the previous minutes were read and checked for accuracy. It was requested that an amendment be made to item f regarding parking on the green before approval could be given and also to chase up a response from Pembrokeshire coast national park regarding the site visit to Home farm barns.

**4. Matters Arising:**

**a) Fortunes Frolic:** An email response had been received from Cllr Lewis to inform that Mr Sean Tilling is the contact for the site visit we have requested that Cllr Lewis and Mr Tilling contact either Mrs Wililams/Mrs Green or Mrs Campbell in order for a visit to be arranged.

b) Ditches: Mrs Green raised the issue of the ditches in the locality causing major problems for a few motorists that have recently got stuck in them, her husband had to rescue a motorist using the tractor as the car could not be freed. Clerk to email Cllr Lewis regarding this issue. Mrs Green has full details if required.

c) C/fwd Letter to Ambulance Service – at previous meeting Cllr Percy requested a letter be written to Ambulance service but has yet to clarify with clerk what content the letter should take. Mrs Lloyd would like Mr Percy to draft letter then she will send off as she is unclear about what he would like to express.

Action – Clerk and Mr Percy to prepare letter.

d) (i)Traffic in the Village: Recent accident outside church this was caused by increase traffic following the closure of St Martins Church and more congregation using our local church. There has been an increased in speeding and a car has also had to be rescued from the ditch. (see item 4b);

(ii) There has also been noted some problems in relation to a French drain at the Rhos and this has caused traffic difficulties. The creamston to Millin Road.

(iii) Cllr Hancock brought up works on the A40 to wards wiston, the road is closed and if there is an accident requiring diversion there is currently no way that traffic can be diverted safely, it was asked to request Cllr Lewis to clarify what contingency is in place. Clerk to request Cllr Lewis to contact Mr Hancock re this, and Mrs Green re the ditches and Creamston Road.

Action: Clerk to update Cllr Lewis.

e) Local Schools: It was suggested that Community Council send a letter of support to local Governors to show our support about downgrading of 6<sup>th</sup> Form, this will have an effect on teaching staff as well as pupils and they County Council are not looking at the outcomes of the students.
