Minutes of September monthly meeting

The minutes were agreed as an accurate record, and signed by the Chairman (proposer C'llr Paddy McNamara, seconder C'llr Alun Williams).

Matters Arising

Lease of playing field. C'llr Paddy McNamara had been in contact with the solicitor for the Diocesan Board, raising some issues regarding the proposed use of the land, and the pavilion building thereon. These matters were currently under consideration by the Diocesan Board. The yearly rate was constrained by their charitable status. C'llr Paddy McNamara also made some comments about possible ways to deal with the practicalities of parking vehicles on the land. Members were happy for C'llr Paddy McNamara to continue with the lease negotiations substantively on the basis of the lease terms offered. Matter to be placed on each agenda until further notice.

Lorries coming from Benton Woods. C'llr Michael Pettit mentioned that lorries coming to and fro from Benton Woods, especially along New Wells Road, were causing problems, due to being bunched up, which presented problems when meeting oncoming traffic. C'llr Alun Williams mentioned that he thought the lorries were meant to be routed along Ashdale Lane. Clerk to write to NRW about the matter, mentioning the agreed route, and requesting spacing of lorries to minimise problems.

Discussion of possible defibrillator provision within Community

C'llr Nia Phillips mentioned that the Jubilee Hall Committee had not managed to obtain funding for a defibrillator. C'llr Derek Jones mentioned that a discount on purchase price could be obtained via the British Heart Foundation. Clerk to write to B.H.F. to seek their advice. Clerk also to write to Welsh Ambulance Service. Clerk to check back on minutes from historic minutes (possibly around 18 months ago) to see if any record had been made of possible free defibrillators on offer.

Any Other Business

Care Home, New Wells Road. Clerk indicated that he would request an investigation into the size of the care home. Also check the plans to see the size of the property.

Bus shelter refurbishment. C'llrs Derek Jones / Roger Scrimshaw had carried out this. Members expressed their thanks for the work undertaken.
