- I. Apologies - None
- II. Receive and confirm minutes of last meeting dated 1<sup>st</sup> July 2015.
- III. Matters arising
  - a. Angle School amalgamation – ACC response letter to be uploaded to PCC Website. Clerk to complete.
  - b. Footpath from Chapel Bay Fort to West Angle Beach – Tabled response from PCC. Negative for funding, suggestion was raised to apply to National Parks for assistance. Clerk to follow up.
  - c. War Memorial Funding – Cllr Richards has now three quotes for work on the two tablets outside the Village Hall. Cllr Richards to follow up on grant application.
  - d. Acknowledgement of resignation – Mark Taylor / Job Vacancy Notice – Waiting on official resignation from Mark Taylor before posting “*Notice of Casual Vacancy*” Form.

- d. Grants for cycle path or pathway – Clerk to write to Simon Hart asking if there are any grants or associations who could help with placing a path/cycle way from West Angle Beach to Angle Village.
- e. Send a request to PCC for their official policy on the swapping of Council houses. Recently it was brought to the attention of Angle Councillors that a Council house in Angle Village was part of a three way swap with families from other communities, depriving local families of a local home. Clerk to follow up.
