#### 15/096 Planning:

Applications Received:

15/0771/PA: Field East of Cott Lane, Cross Hands, Narberth.

Council commented the proposed developer should carry all costs of Cott Lane up to their gateway and adopt the lane. The Council felt the public/public funds should not pay for upkeep of road if being used for a commercial venture.

Planning - Other:

Council commented on the repetitiveness with which Bluestone put in retrospective planning permission. Recently there have been at least 2 retrospective planning applications for large scale works. Each time planning is granted. The planning rules should cover everyone and the process should be the same for everyone, regardless of whether a private or commercial applicant. The Council would not wish planning procedures to appear to be bought into disrepute by consistent flouting of the rules for some applications.
