# MINUTES OF THE MEETING HELD ON THURSDAY 7th APRIL 2016.

3773. Cllr George welcomed everyone to the meeting and invited Mr Hassan to speak. Mr Hassan said that he was complaining about the speed of vehicles travelling through Thornton, that despite there being road bumps, vehicles were straddling the bumps and driving at excessive speeds. It was made more dangerous by the fact that there was no pavement in the village.

Cllr Rowlands suggested writing to the Police, supporting Mr Hassan's complaint and that the matter should also bebrought up again at the Police Forum. Cllr Yates would mention it. Cllr Thorne suggested getting PCC to infill the bumps so they could no longer be straddled, therby reducing the speed of vehicles.

Cllr George said that there was two options, enforcement or prevention, with perhaps the best option being prevention.

It was agreed by the meeting that the Clerk write to Ben Blake, PCC, asking for the bumps to be infilled. And also write to Dyfed Powys Police asking for police attendance and enforcement action, also to establish from the police how Speed Awareness Volunteers would be used. If Tiers Cross volunteers were used other villages, would volunteers from other villages be used in Tiers Cross. Mr Hassan then left the meeting.

# MATTERS ARISING.

# 3775. Solar Fund.

Cllr Thorne said that the cheques issued on behalf of the Solar Fund the previous month had been returned due a misunderstanding over authorised signatories. This problem had now been resolved and the cheques had been re-issued.

#### 3776. Defibrillators.

The Clerk said that he would contact Jayne |Lewis, British Heart Foundation to establish what the position was with grants.

#### 3777. Bulford Road.

Cllr Bullimore produced plans drawn up by PCC, showing proposed improvements to the Old Bulford Road. He said he would have preferred meeting with PCC before they had prepared the plans, so that there was local input into the improvements. Cllr Rowlands said that he would arrange a site meeting between PCC, Phil Legget, and Cllr Bullinore.

3778. Meeting with Quarry Management.

Cllr Rowlands said that he had spoken to the quarry manager and he would be attending the meeting of Johnson Community Council on Monday 11<sup>th</sup> April 2016 to discuss items relating to Johnson. He asked if members would like to attend this meeting or have a seperate meeting with the manager. It was agreed that the list of complaints raided by Tiers Cross be raised at the meeting in Johnson. Cllr Yates and Cllr Jones would attend. If the outcome was not satisfactory another meeting would be arranged.

3779. PCC Consultation Meeting.

This had not yet been arranged.

3780. Memorial Garden.

The Clerk read a letter from the committee of the Memorial Garden stating that this was the last year that they would be able to do the maintenance of the garden. This was due to advancing years. It was agreed that a letter be sent to Mr & Mrs Haworth thanking them for all their hard work. The Clerk would place a notice on the board asking for volunteers to assist in the care of the garden.

3781. Rare Plants.

Cllr Thorne had passed on the information to the resident who had raised the query.

3782. Vehicles parked on pavement near garage.

The Clerk said that he had received an email from the mechanics working at the garage and had spoken to them on the phone. Cllr Rawlinson said that there was still a lot of cars parked there. She also mentioned that the occupants of No 1 Red Bath View had placed a notice outside their premised stating it was private parking when it was in fact a public road. It was also reported that there two vehicles parked near the entrance to the Bulford Road which did not look road worthy. The Clerk would pass this information on to Street Care, PCC.
