The end of year Summary of Payments and Receipts was presented to the meeting and was approved, proposed by Cllr Gwenfair Mason and seconded by Cllr Nicola Merriman and agreed unanimously. The Clerk will complete the necessary documents for submission to Grant Thornton for external audit. It was agreed that Colin John of

Llewellyn Davies in Narberth be asked to carry out the internal audit as has been done in previous years accepting that there is now a charge for this service.

#### Review of financial risk assessment and standing orders:

## 6. County Councillor's Report

- ➤ David offered his congratulations to Glyn Jones as the new Chair and thanks to the outgoing Chair Charles James.
- > Stile has been ordered for Lampeter Velfrey and will be installed in next few months
- ➤ Name of the road at the back of Tavernspite village is in dispute if it is officially labelled as Lime Road some properties would need to have their postcodes changed. It was suggested that the Community Council can put a sign up that says historically known as Lime Road; it was proposed by Cllr Charles James and seconded by Cllr Barbara Williams.
- ➤ No stop sign at Ash Lane going on to Lime Road it has been ordered.
- Drainage around Ludchurch Farm pipework will be improved.
- > 30 MPH through Ludchurch and Princes Gate
- Road dressing programme is underway
- Mr James in Ludchurch tipped waste has been removed
- Councillors agreed that the planning notices that David is sending out are useful
- ➤ David explained that Tavernspite village Hall has been successful in being awarded funding from the Aggregates Levy Fund but that match funding is needed. It was agreed to donate £500 towards this.
