MINUTES OF THE MAY MEETING

3816. The minutes of the meeting held on Friday 6th \May 2016 were passed as a true record. Proposed by Cllr Thorne and seconded by Cllr Rawlinson.

MATTERS ARISING.

3817. Speed of vehicles in Thornton.

The Clerk said he had not received a reply from Ben Blake at PCC. Cllr Rowlands said that he would speak to Ben Blake regarding the matter.

3818. Defibrillator.

An email had been received from British Heart Foundation stating that grants were now available. Cllr's George and Thorne will liaise in submitting the form.

3819. Meeting regarding superfast broadband.

Cllr Thorne had been unable to attend the meeting but he had emailed Stephen Crabb regarding the problems with broadband in the area.

3820. Pension Regulator.
