MINUTES OF THE MEETING HELD ON THURSDAY 3<sup>rd</sup> NOVEMBER 2016

3879. APOLOGIES FOR ABSENCE.

There were no apologies.

3880. DECLARATION OF INTEREST.

Cllr George declared an interest as an employee of Pembrokeshire County Council and signed the form.

3881. PUBLIC FORUM.

Cllr George invited the members of the public to address the meeting if they had any comments to make.

Mr & Mrs Boulton commented on the increase of traffic in the village, the speed of vehicles travelling through the village, particularly lorries and parking problems. He asked if it would be possible to issue resident parking permits to prevent holiday makers and visitors, leaving their vehicles in the parking spaces, often all day.

He also felt that because the 30mph speed restriction signs were before the roundabout, people were coming off the roundabout into the village and increasing their speed as if they were forgetting about the speed limit.

Both Cllr George and C. Cllr Rowlands replied, stating that the community council were working together with the county council to prepare a village plan, which it was hoped would alleviate some of the problems.

The Clerk was instructed to write to the county council asking for 30mph signs to be placed after the roundabout.
