3897. APLOGIES FOR ABSENCE.

There were no apologies, all councillors were present.

3898. DECLARATION OF INTEREST.

Cllr George declared an interest as an employee of Pembrokeshire County Council and signed the appropriate form.

3899. PUBLIC FORUM.

The Chair welcomed everyone to the meeting and invited Mr Warlow to address the meeting. Mr Warlow said that he lived next door to the Memorial Garden and would be willing to take on the maintenance of the garden at no cost to the council. In consideration he would like to purchase a piece of unused land in the memorial garden to his own use.

Cllr George responded by saying that the council were grateful for the offer but there were other options which would have to be considered, also the deeds would have to be checked and a valuation done.

The Clerk would keep Mr Warlow informed.

There were no further comments or questions.

3900. MINUTES OF THE LAST MEETING.

The minutes of the meeting held on Thursday 3rd November 2016 were passed as a true record.

3901. MATTERS ARISING.

(b). C. Cllr Rowlands produced a plan showing how the entrance to the Old Bulford Road could be improved and made to look more attractive. A discussion followed in which several points were raised regarding the plans and traffic calming measures were also mentioned.

It was proposed by Cllr George that a village meeting be called in January to discuss the matter and obtain the public view. This was agreed by the meeting.

3902. SOLAR FUND.

Cllr George and Cllr Bullimore gave details of a meeting they had attended with Ben Ferguson-Walker, (Welsh Government Local Energy Development Officer). The meeting was to discuss various means of utilising the solar fund income for the benefit of the community.

Mr Ferguson-Walker would prepare some proposals whilst Cllr's George and Bullimore would draw up a list of stakeholders in the community. This matter would also be discussed at the community meeting in January. It was agreed to invite Mr Ferguson-Walker to the March meeting to discuss the proposals. Cllr George would liaise with Mr Ferguson-Walker,
