vi. Village Warden.

I t was decided to leave the appointment of a new village warden until after the May election. It was suggested that the new council might ask for volunteers to assist with the litter picking.

vii. Mud on road.

Both Cllr's Lloyd and Owens made comments about the amount of mud on various roads in the village. Following a discussion it was agreed that the Clerk would invite the Sergeant at the Roads Policing Unit at Haverfordwest to visit the village and meet with the councillors
