1. Matters arising:

1. Footpath to West Angle Bay.

ACC have received Correspondence from PCNPA re proposed plans for pathway. Cllrs concerned about safety issues in particular visibility and, request a site visit with representation from the Angle Estate and PCNPA +/- PCC

4. Planning issues.

1. Village phone box

We have been successful in securing the retention of a village public phone box. Re connection pending. This will need to be used to ensure ongoing availability. **Resolved**

5. Highway Matters

1. Resurfacing of Road in Angle.

This has been reviewed by PCC who agree this needs to be addressed but due to budget restrictions there is no time limit on this.

2. Village speed limit. - Questionnaire circulated. Responses required by end of April.

6. Meetings attended by Councillors

1. **AVH** – attended by Cllr Hill. Who reported that Angle school representatives were requesting financial support for the “end of an era” celebration of the school once it merges with Hundleton and Stackpole in September 2017.
2. **Valero** – Cllr Richards re-enforced the Valero rep presentation.
3. **LDP workshop** – On behalf of ACC, the clerk attended this meeting, which was very insightful into the process of the Planning process for those who want to develop and those who wish to protect the land as it is.
4. Power Station – concern that ACC have missed a recent meeting.

1. Requests for funding from several charities. Chair updated Councillors that there was a prior agreement that to keep the precept as low as possible, as such requests were not supported by ACC.
2. Training modules from One voice Wales who are trying to arrange courses in Pembrokeshire to minimise travel distances. Deferred until May
3. Application to join One voice wales at 50% reduction i.e cost of £29.00 ACC in favour, especially as they are good at circulating relevant information.
