Charity donations

It was agreed to send £100 each to H.O.P.E., Burton Toddler Group, and Pembrokeshire Cruse. The above items were approved by Members (Proposer C'llr Clare Zawadzki, seconder C'llr Laurence Price).

Discussion of possible bus shelter replacement at Bowlings Corner

No response had yet been received from Hook LNG in response to the letter requesting grant assistance towards the cost of installing a bus shelter. Matter deferred to April to give more time for a response to be received. In the meantime C'llr Michael Pettit said he would make a telephone call to chase up the matter. It was agreed that a decision would definitely be made next month.

Discussion of flooding problem, Foxhall

C'llr Clare Zawadzki said that the problem had got worse during the last month. C'llr Rob Summons had mentioned that the deadline for getting the drain installed at the western end was close. C'llr Clare Zawadzki was concerned over water coming out of Butterhill Lane, close to the junction with the Port Lion Road. The comment was made that, being a private lane, the responsibility may well lie with the owner. Matter to be placed on April agenda for further discussion, by which time it was hoped that the work on the western end would be completed.

Discussion of possible verge encroachment, Elidyr Park

C'llr Clare Zawadzki thought that the land in question was privately owned. There was some discussion over the maintenance of the land (thought to be done by P.C.C. contractors). Clerk to write to ask if the timber supports breached a planning consent.

Discussion of postbox, Bowlings Corner

Clerk to ask P.C.C. for a quotation to install a footpath wide enough for a wheelchair.

Discussion of issues surrounding closure of toilet block, Burton Ferry

C'llr Laurence Price mentioned that the toilets should be opened. It was pointed out that as a private covenant, it could only be enforced by the covenanter. C'llr Laurence Price asked if the covenant could be acquired by the Community Council. Clerk to investigate this. Matter to be placed on April agenda for further discussion.

Any Other Business

Attendance at Governors' meetings, Cleddau Reach School. Nothing heard. Clerk to chase up again.

Flytipping, Quarry, Foxhall. Clerk to contact PCNPA. Clerk to speak to Common Lands Officer.

Beach-cleaning. C'llr John Mathias had raised the issue. He thought that Joan Palmer had previously arranged this through a young offenders organisation. The Community Council had not previously had any involvement in this. Matter to be placed on April agenda for discussion. **Noticeboard.** A problem had been noted with tight locks on some noticeboards.
