17/051 Minutes of previous meeting: The Minutes of the May Ordinary Meeting were taken as read, and signed by Chairman Eynon as a true & accurate records.

### 17/052 Matters arising

**Historic Local Place Names:** Chairman Eynon reported Mr Peter Elliot is still in the process of completing the map for Tedion Farm. Advance to next meeting.

**Public Noticeboards:** Chairman Eynon reported he is still in communication with Mr J Crowther and the matter of the refurbished boards will be settled soon.

**Defibrillators:** No further action at present. Awaiting responses from Western Power and BT. There is now also the matter of land ownership recently raised by Pembrokeshire County Council (see Adopt-a-Kiosk item below). Advance to next meeting.

Adopt-a-Kiosk: Clerk reported she is awaiting responses from both Western Power and BT. Western Power have been asked to confirm they will continue to supply electricity and it will be free of cost. BT must get back to Clerk with regard the two different types of kiosk as minuted in the May meeting. County Councillor Clements has also raised the issue of the response from the pertinent department within Pembrokeshire County Council with regard to ownership of the land upon which the kiosks sit. It was unanimously agreed by Councillors present at the meeting that the legal implications of ownership of the land must be cleared up prior to further action. County Councillor Clements will look into this matter further and report to the Community Council at the next meeting.

#### 17/053 Planning

## a. Planning Applications Received:

i PCNP: NP/17/0282/TPO. Works to Trees St Caradog Church, Lawrenny, SA68 0PY. Following close inspection of the application the Community Councillors unanimously agreed there were no comments to be made to this application.

ii PCC: 17/0134/CL. Furzehill Farm, Martletwy, SA67 8AN. Residential Caravan & Surrounds. Prior to discussion of this application and 17/0132/PA (below) the Community Councillors expressed their sadness on hearing of the recent death of Mr Paul Higginson of Furzehill Farm and were unanimous in their sympathy towards Mrs Val Rees and her family.

This application was considered in great detail. Community Councillors registered their disappointment that this matter was not raised by Pembrokeshire County Council earlier and questioned why the removal of the caravan was not made a condition of the approval of the original planning application. The Councillors were unanimous in their opinion the failings of Pembrokeshire County Council were responsible for the likely success of this application.

The planning application was studied in great detail. Chairman Eynon stated the property could be a good small farm and would retain farming in the area. Chairman Eynon also raised the issue of the possibility the property may not have sold because the property and land had been incorrectly valued and not taken into consideration the agricultural occupancy restriction. Having considered this application in detail and following a full and frank discussion Martletwy Community Councillors unanimously agreed they were of the strong opinion the agricultural occupancy restriction should be retained on the land and the house and requested the Clerk make representations to Pembrokeshire County Council to this effect.

17/054: Highway Matters

**a. Grit Bins:** Chairman Eynon reported on positive feedback received from the recipients of the thank you letter in regards the Coedcanlas Grit Bin. Councillors discussed the positioning of possible additional Grit Bins. It was unanimously agreed Burnett's Hill would be a good location. Councillor's agreed in principle additional Grit Bins would be a useful addition to the community. Cllr Williams raised the point it had originally been suggested a new Grit Bin be purchased annually until all areas were equip. All Councillor's unanimously agreed this remained in scope.

#### b. New Matters arising:

- i. <u>Bladon Cross. Give Way Sign. Knocked Down.</u> Reported by Cllr Gill Williams. The sign has been dislodged by a vehicle. Clerk to report to Pembrokeshire County Council requesting remedial work.
- ii. <u>Section of road between Burnetts Hill & Curly Wells.</u> Reported by County Councillor Clements. Surface starting to break up. Road requires digging out and resurfacing. Clerk to report to PCC. iii <u>Baptist Church to Cwm Deri Vineyard, Martletwy.</u> Highway surface here also requires remedial work. Clerk to report to PCC.
- iv. <u>Garron Pill, Lawrenny.</u> Reported by Chairman Eynon. A car became stuck in the flood water recently at Garron Pill. Chairman Eynon requested Clerk ask PCC to investigate the issues regarding the measuring pole and the actual depth of water thoughout the whole length of the flooded road.
