40. APOLOGIES. Cllr E. Jones.

41. DECLARATIONS OF INTERESTS,
Cllr George declared an interest as an employee of Pembrokeshire County Hall.

42. QUESTIONS FROM THE PUBLIC.

43. MINUTES OF THE PREVIOUS MEETING.
The minutes of the previous meeting were passed as a true record. Proposed by Cllr Rawlinson and seconded by Cllr Bullimore.

44. MATTERS ARISING.
Parking permits for residents. It was agreed by the meeting that the Clerk would write to the head of the Highways Department at PCC, asking if it would be possible to introduce a resident parking permit policy or any other solution to the parking problems in the village

Speed of Quarry vehicles. Cllr Rowlands will speak to the quarry operators.

Speed bumps at Thornton. Cllr George would make further enquiries with PCC and the matter would be discussed at the next meeting. (agenda)

Bus shelter request from the Havens Community Council. Cllr Rowlands will attend to the matter.

Cllr Thorne declared an interest and took no part in the discussion. Cllr George proposed that the Solar Fund give a sum of two hundred pounds to support local youngsters. This was seconded by Cllr Bullimore and agreed by the meeting.
