

**Angle Community Council**  
**Minutes of the meeting held in Angle Village Hall**

9th July, 2014 at 7.30pm

**Meeting commenced 7.30pm.**

**I. Apologies – Mr Mark Taylor.**

**II. Approval of minutes from last meeting dated 28<sup>th</sup> May 2014.**

The minutes were approved as read. Proposed by J. Powell and seconded by B. Brown.

**III. Matters Arising**

- a) Stream digging – No work carried out as of yet. Mr Glenville Codd (Area Maintenance PCC) has been contacted. Look at this issue at the next meeting. Jo Powell was in touch with PCC Rep (A. Wood) he said the stream is scheduled to be done once the kids breakup for summer holidays.
- b) Community Council webpage development – This is now live and open to the general public. Agendas and meeting minutes are now available to view online. Web address for this is <http://www.pembstcc.co.uk/>.
- c) Village Hall Toilets – ACC do not currently have available finances to help with the running costs of the toilets at Angle Village Hall. The committees request to increase the precept has been noted, however, the amount is now set for this year and is not due for review until December.
- d) Gupton Farm/Freshwater West public access - Jo Powell, Brian Brown and Gerald James have been attending relevant meetings. Councillors present are not in objection to the public access, however they are keen to be kept informed of any development. No further information on this issue has arrived.

#### **IV. South Hook CPH Power Station.**

Cllr D. Richards confirmed that there is no planning permission or development as of yet. He will be attending a meeting on Thursday 10<sup>th</sup> July 2014 for an update. There were no objections for the exploration pilot hole to go ahead.

#### **V. Solar developments & renewable energy.**

a) Broomhill Wind Turbine - Angle Community Council have sent their response to appeal for this development. No decision has been made at this time.

b) Rhoscrowther Wind Farm – The Council has requested an update for Application no. 13/0876/PA. As yet it has not been scheduled to go to the planning committee. Teresa to calendar note, to re-request update in 4 weeks time.

c) Overnight Parking at West Angle Bay - Angle Community Council and Pembrokeshire Coast held a public meeting at Angle Village Hall on 2<sup>nd</sup> July 2014. Still waiting on an agreement for parking order through Pembrokeshire County Council. Till the parking order is in place, Pembrokeshire Coast are looking into erecting a high barrier across the front wall of the carpark that will only allow cars under it. Larger vehicles will have to park behind the second wall. While some Councillors are for this barrier, there are others against it. Decisions will be made if and/or when Pembrokeshire Coast comes up with design ideas. No further action by ACC was proposed.
