#### 123. PRESENT

## Any other business

134. Councillors expressed concern to the pending new arrangements for recycling domestic waste. The introduction of kerbside collection was a matter of significant concern to the members. Clerk was instructed to write to Cllr Cris Tomos Cabinet member for Environment to ascertain what exactly was being proposed and to outline the members concerns.
135. Cllr Alan Ford suggested a notice board should be located on the wall of the old school yard

Abercych as very few people enter the Millennium garden to read the current board. Members had mixed views on the matter, it was suggested in the first instance to ascertain whether the owners of the wall would allow a notice board to be placed on their wall.
