- (c) VAT: Re: Invoice 10026 dated 07.11.18 for £190.00 + £38.00 Vat in respect of the Jeffreyston Information Panel. During a recent application to HMRC to claim a refund of the vat paid, the clerk discovered that the vat had been incorrectly charged to the community council. She has advised the business owner and requested a refund of £38.00
- (d) Notice of Audit for financial year ended 31.03.19: Clerk reported that she had received the 2019 annual return and associated paperwork for completion. The papers and accounts will be delivered to the Internal Auditor before submitting to the Council for their approval prior to returning to Grant Thornton, the External Auditors, by the due date.
- (e) Audit Fees for Community & Town Councils: Clerk reported that a letter accompanying the Audit pack explained the delay in the issue of the 2017/18 audit fee invoices. It appears that Grant Thornton identified an administrative error between 2015 and 2018 resulting in audit fees being undercharged for each year. The Wales Audit Office will not pass on the additional costs to councils. The error has now been corrected and means that councils may see an increase in the fee for 2018/19 compared to previous years.
