Minutes of the meeting held at Newchapel Reading Room on Tuesday the 11th of June 2019 at 7.45p.m

### Minutes of the AGM and monthly meeting held on the 7<sup>th</sup> May 2019.

18. After circulation of the minutes, they were signed by the Chairman as a correct record. It was a unanimous decision proposed by Cllr Liz Hall and seconded by Cllr Aled Lewis.

### Matters arising from the minutes of the last meeting.

19. Final Audit submitted on the 5<sup>th</sup> June 2019 as previously presented at the AGM – was noted.

20. Second Notice Board Abercych Location – Following further inspection of alternative sites, it was agreed that the wall opposite Mill Road T junction was not suitable. It was agreed to approach the owner of Maes yr Onnen Mr Gareth Davies to ascertain if he would be willing for the Notice Board to be placed on the end wall of his property.

21. Flowers to be planted by Richard Wilson. It was confirmed that the flowers would be planted within the next two weeks.

22. Millennium Garden and Newchapel Playing Field Benches – delivered. Clerk wished to thank Cllr Aled Lewis for assisting in the delivery of the two benches. Given the weight of the benches it was agreed that there was no need to provide a concrete base for the benches. Newchapel Playing Field had written to thank the Council for the provision of the high quality bench.

23. Site meeting at Newbridge between Ceredigion and Chairman. It was reported by the Chairman that further temporary work would be completed by Ceredigion until funding is established for more permanent improvement work.

24. Annual Dinner - Chairman's Allowance = £83.50p. The sum paid was approved and everybody wished to express their appreciation and gratitude for the welcome and the high standard of the meal provided by the Nags Head.
