### **Update on current issues**

- 1. Stackpole VC School-sale no further updates at the time of the meeting.
- 2. St. Twynnells Bus Shelter –. Helen McLeod-Baikie is looking into the cost of the lease. No update at the time of the meeting. The councillors asked the clerk to make contact with Helen Mcleod-Baikie.
- **3. Buckspool Farm Pot Hole** Councillor Steve Alderman to speak to Simon Davies and provide a solution.
- **4. Street Lights –**The streetlight opposite Windsor House in Castlemartin has now been repaired.
- **5. Fly Tipping –** The fly tipping has chucked into Valast Hill email from PCC requesting exact location. The clerk to provide location with explanation that the fly tipping has been thrown into the hedgerows of Valast Hill.
- **6.** Pot Hole The pothole has now been repaired.
- 7. Visually Assisted Sign the clerk will contact Pembrokeshire County Council to find out if there is any grant funding that may be available to pay for a virtually assisted sign.
