Cllr D. Thomas had replied to PCC offering no objections but listing a few observations regarding the porch ans access to parking area.

18/0993/PA. Variation of condition 2 of planning approval to allow for an amendment to the approved scheme. Cllr D. Thomas said that the council did not have any objections.

Caravan Park in Beulah Fields. Cllr Thomas said that no application had been submitted for a candidate site in either of the LDP application windows.

10. Village Hall.

Cllr D. Thomas said that with regard to the heating improvement, Bullock Consultants either did not seem interested or did not have the manpower available to visit the hall. Cllr Thomas had found a website for an infrared heating system, which would appear to be offering considerable benefits. He was trying to locate a local supplier/installer.

drainage work for approx. £4500.00 It was proposed by CllR Utting and seconded by Cllr D. Harries that we accept the quote and ask them to proceed.

- d.PCC had removed the wooden benches from the childrens playarea. The reason they gave was that the wood was rotten in parts. No notification had been received regarding the removal.
