- 80. Balance as of 08/10/19 net of all outstanding cheques Treasures Acc £2,410.59p. was seen and noted.
- 81. Quarterly budget Monitoring Photocopy of latest Bank Statement provided, with this year's budgeted spend. End of year balance to be **crica £1,451.59p**. Budgeted Expenditure to year end are as follows –

£792 - Clerk half year salary inclusive of PAYE costs

£350 est – Grounds maintenance Costs.

£600 est – S137 Local and general donations

£300 est - Audit fee

£190 - Rental and deflib costs.

£100 est – Miscellaneous

£750 - Election Cost Reserve

Total Expenditure = £3,082 – Income of £2,410.59p + £1,833.00 precept + £290 est Vat reimbursement = Total income of circa £4,533.59 - £3,082 = Predicted balance of est £1,451.59p - was seen and noted with all in agreement with the report.

82. 2020/21 Budget Requirement

Based on forward commitments and a need to maintain a £1,000 general reserve and last year spend with a 2.5 % inflation factor, budget requirement for 2020/21 would be circa £4,500.00 less surplus of est £451.59p = Requirement of Circa £4,200 + any new initiatives for 2020/21 Current Precept £5,500. Cllrs agreed to decide the Precept level for 20/21 at the November meeting when consideration of any funding commitments for the next financial would also be finalised.

83. A cheque for £50 was received from Mr Edward Collins of Home James Taxis as sponsorship for part cost of the flowers for the 2019 season. Cllrs thanked Mr Collins for his generosity and Clerk would write to convey the thanks.

84. Deputy Clerk raised the issue the Defibrillator at Abercych had still not been registered with the Wales Ambulance Service. Cllr Ford would follow the matter up with the Hall Committee.
