
## KILGETTY - BEGELLY COMMUNITY COUNCIL (KBCC)

a) 19/0838/PA Ryelands Caravan Park, Ryelands Lane, Kilgetty, Pembrokeshire, SA68 OUY

Remove/vary condition 4 (restrict use of site and occupancy of touring caravan pitches) and vary wording of Conditions 6 (Buffer Zone Management Plan), 7 (External Lighting Plan) and 10 (Landscaping Implementation Programme) of Planning Permission Ref: 18/1217/PA (enlarging area of caravan site, erection of meet and great building, children's play area, new roads and landscaping)

Following discussion, it was agreed that the above conditions were put in place by the Pembrokeshire County Council Planning Authority to ensure that the site is not used as a 12 months of the year residents park, (historically - this restriction was requested to be removed and refused). Information and reports from other Authorities are incomplete or not published and considered inaccurate information being supplied.
