102/21 Actions required in respect of the new Local Government and Elections (Wales) Act 2021

A summary of the provisions of the Act had been circulated to members for their information. Two matters currently requiring attention relate to the publication of a summary of meetings within 7 working days and arrangements for the continuation of remote meetings.

Long term, from the 01.04.2022, community councils have a duty to prepare and publish an annual report on the council's priorities, activities and achievements. Each council will also have a duty to prepare a training plan.

Resolved:

1. Draft minutes of each council meeting to be published on the Pembrokeshire Town & Community Council web page within 7 working days of each meeting.

2. Meetings to continue to be held on a remote basis for the time being subject to review of Welsh Government guidance concerning the safe use of buildings for council meetings. Online access information to be displayed on Agenda for anyone wishing to join the meeting.

103/21 Ford Bridge Update: Following further correspondence with PCC, a more comprehensive response had been received giving reasons for the delay and an assurance made that regular safety checks are being undertaken. Resolved: Councillor Everall to speak with the Headmaster of St Oswald's to see whether the school children could be involved in some way.

105/21 Discussion on LCREE Survey for the Office of National Statistics

107/21 Discussion on Service Level Agreement between Jeffreyston Community Council and

Pembrokeshire County Council (PCC). Clerk had forwarded the Annual Independent Inspection Report undertaken in February 2021. Some low risks had been identified in previous years to PCC that were still outstanding. From the 01.04.2021 the Community Council are responsible for repairs and maintenance, addressing low risk items within 6 months.

Resolved: Council were satisfied that the correspondence received from PCC confirmed that the community council were not expected to address the issues notified in previous years. Clerk asked to arrange a meeting between the community council and the inspectors when they next visit the play area.
