20/70 PCC Report

MB stated that Covid was still a matter of concern with rates increasing. The Bluestone Hospital had been brought into use and PCC are assisting with Vaccination rollout. The return of schools was still uncertain. Business support grants have been funded by Welsh Government. A consultation had been published for the PCC budget for 2021/22, which was around £14.5M and MB urged all to respond. BH queried spending over £4M on regeneration of Haverfordwest Town Centre. MB explained that the money for this would come from a Capital budget which cannot be used for revenue costs.

20/80 Commons Car Park: PW stated that an agreement had been reached with Evan-Pritchard contractors to pay £1,000 for the use of the car park at the Commons for storing equipment whilst working in the area. S Jones to pass details for payment. HJ thanked PW for all his hard work in getting a contract drawn up.

20/81 Foodbank: PW noted that a food deposit box has been placed on St Davids Road for the residents of the village and urged members to support it or make contributions.

20/82 Potholes: GT reported that there were several potholes on the back road from the A40 to Clynderwen Farmers.

20/83 Station Road: AA asked if we could explore how to get a footpath / pavement from Parc Maen Hir to the junction by Clynderwen Farmers. SJ to contact PCC.
