268. Questions from the Public.

Councillor George invited Mrs Bacon to address the meeting. Mrs Bacon said that wanted to discuss Capeston Poultry Farm and she was concerned at the amount of sheds that were appearing in the St Botolphs area. She had spoken to the Planning Department at PCC who had told her that most chicken sheds did not require planning permission as if they did not have a floor then they were mobile structures,, This only applied to sites which had less than 40,000 birds. If there were over 40,000 birds then different rules applied and the sheds needed floors.

Mrs Bacon said she was also concerned about the air quality being affected by the ammonia. She had lodged her concerns with Natural Resources Wales, who were investigating.

Cllr George asked what she expected the council to do. Mrs Bacon said that if the council could register their interest in the scheme with Natural Resources Wales and enquire of them what was the latest situation.

Cllr. George thanked Mrs Bacon for attending and raising the matter. Mrs Bacon left the meeting.
