## Meeting of Lamphey Community Council meeting held on 24th January 2022

In attendance were:- Cllr N Vince, Cllr S Cannon, Cllr D Phillips, Cllr J Purser, Cllr A Skeels, Cllr J Vince, Cllr L Scourfield, County Cllr T Hodgson and Mrs P Davies (Clerk)

Apologies were received from Cllr H John (working) Cllr R Tallis

Cllr N Vince chaired the meeting.

The following topics were discussed and decisions were made:-

- The new noticeboard had been fitted to the Village Hall.
- No update from PCC on hedgecutting.
- A response from PCC was circulated in connection with cars parking on the pavement.
   After discussion is was decided to write to PCC and request that they install bollards to deter people from parking on the pavement.
- Cllr J Vince had spoken to Chris Taylor from PCNP and the Clerk to arrange a meeting and book the hall for a date that is suitable for all parties.
- The Chair had spoken with the representative from the Church and it was agreed to arrange a meeting between all interested parties soon. Cllr J Purser to take the lead and follow up enquiries and Cllr T Hodgson to help with the enquiries.
- Cllr R Talliss had circulated an update on the defibrillators. A suitable site in Hodgeston
  as the bus shelter was not in the best of condition. Discussion took place on the
  defibrillators in the community and their condition and when equipment would need
  changing and where new equipment would be sourced from.
- A letter from Mr J Parson had been received that afternoon. The Church were submitting a grant application for a new bench to be sited in the new churchyard. Resolved that a letter of support to be written.
- Cllr R Talliss had now obtained an email address for Welsh Water and his letter could be sent with regard to the recent sewerage incident.
- Lamphey School the vision statement would be ready in the autumn.
- Cllr T Hodgson to make enquiries as to whether PCC own the strip of land by Honeyhill as Lamphey School were looking for land to plant trees.
- Report from County Councillor T Hodgson attended a liaison meeting with Sgt Lewis Simpson and the anti-social behaviour at Freshwater East during the summer was discussed. Sgt Lewis to possibly attend the March meeting.
- Cllr T Hodgson had also been in touch with the Highways at PCC and the date for the highway repairs in Lamphey had now been pushed back to mid-February. Councillors were disappointed at this response as some of the matters raised had been ongoing since last summer. Cllr Hodgson was meeting with the new Chief Exec the following morning and would bring these matters to his attention.
- Following a request from the Clerk for the viewing figures for the Lamphey Community Council website Cllr Hodgson had obtained the figures from the IT Dept and the Lamphey page was well viewed and is one of the most viewed pages.

- Cllr N Vince had been involved in a tour of the School with a representative of PCC and a list of improvements were promised for the future.

- No update on the land at Freshwater East for a possible play area. February agenda

The Clerk had submitted a request to Valero for the loan of the marquee, pig roast booked, Village Hall available to use and the Village Hall would donate some money towards the event.
