2022/04 164 Planning Application(s) Received

a) NP/22/0151/FUL Castle View, 21, Warlows Meadow, Manorbier

Single storey extension to rear and alterations to South gable end

Following consideration of all the information provided by the Planning Authority, Councillors considered that there was a slight improvement on the previous plans but the majority of Councillors agreed to request that this planning application be refused by the Planning Authority taking into account: -

- The existing building is in a Conservation area in close proximity to the Castle the proposed alterations are not within keeping of the surrounding buildings in anyway, and would be visible from every aspect.
- The proposed plans would create major overdevelopment of the plot, with the proposed building being only 7meters from the neighbouring property.
- Existing neighbouring properties privacy would be greatly impaired with the proposed extension, all constructed with glass, affording sight into all existing neighbouring properties windows and that the folding glass doors will produce a noise when opening and closing, such causing major disruption for the closely located neighbours.
- That there would not be sufficient parking on the plot, possibly forcing persons to park on the estate road causing the turning circle, for all residents to use, becoming jammed and not able to be used for the purpose it was intended for, thus leading to major health and road safety problems.
- b) NP/22/0090/FUL 3, Manor Crescent, Manorbier

Rear single storey extension and two car parking spaces

c) NP/22/0065/FUL Wilmory, Warlows Meadow, Manorbier

Single storey side extensions x 2, alterations to fenestration, rooflights, associated works

Following consideration of all the information provided by the Planning Authority, it was agreed that Manorbier Community Council do not have any concerns or objections regarding the two above planning applications (NP/22/0090/FUL and NP/22/0065/FUL).

It was brought to the Council's attention that, during the high winds, the fence surrounding the Jameston village Hall was severely damaged beyond repair.

The Clerk advised that she had received three prices to supply and erect a new post and rail fence with sheep netting. The prices being

Following consideration of the prices Cllr M Kidney proposed that Manorbier Community Council support the Jameston Village Hall and pay the contractor with the lowest price direct; Cllr Barry seconded the proposal with all Cllrs in full agreement.
