12/22 Declaration of Interest ; None declared.

13/22 Questions from the Public ; No questions.

14/22 Minutes from last Meeting ; The minutes from the last meeting on 8th February 2022 were reviewed and passed as a true record, Proposed by Cllr T.Roberts and seconded by Cllr S.Davey .

15/22 Matters Arising ;

Triplestone Close: Clerk read the reply from Nicola Gandy , director of Planning at National Parks. She stated that as no new application had been received from the developer that they would now be serving a Planning Contravention Notice to him.

Speed Checks ; Clerk told the Cllrs that the members of the public volunteering to complete the training will need to complete ID checks with the police. She will contact them once a date has been given for the training to take place.

Junction to Havens Park ; All work been completed, the new signs are in place , the parking bay has been grassed over and the village sign has been moved to a better location.

Defibrillator Training; Clerk has not had a reply from G.Rothwell , Welsh Ambulance about training , she will chase up again.

Beach Footpath ; Clerk read email from Theresa Nolan, National Parks . She confirmed that the work had been completed to realign the footpath. They are monitoring the groundwork to see how the ground settles once grass grows back to see if any further work needed to improve drainage, on her visit on 16th February she was happy with it. Cllrs have agreed that we will need to monitor this as well.

Beach road bollard ; Clerk was asked to email Andrew Gray & sons to get a price for completing the ground work required to place the bollard at the top of slipway. Clerk has contacted Kelly Morris at Pembrokeshire County council again to ask when they will be putting the sign informing the public not to park in turning bay and place yellow lines along the stretch of road from corner to slip way . PCC still could not give a date for this work to be completed.

Play park ; Clerk still waiting for reply from Pembrokeshire County Council about the Insurance and Inspections to the park. The price indication clerk has received from Neil McCarthy PCC about flooring would require grant funding . Cllr M.Galdo will obtain a quote

for the fencing and clerk will contact a company that can give a quote for flooring so that we have an accurate idea on full cost before starting a grant application.

Village Green Status ; No update.

Beach Car Park; Still waiting for the bill from contractor that completed the ground work.

Lease Agreement ; Clerk confirmed she had handed the completed forms back to Price & Kelway solicitors for them to register with Land Registry. They stated we should have this completed by May.
