# Any necessary discussion of Village maintenance

**Dog fouling signage.** C'llr Roy Venables had put up the two signs, and these were still in situ.

**Village Amenity.** The Clerk had made enquiries with P.A.L.C. An arrangement was in place whereby legal opinions could be obtained for a flat £75 fee. Members decided to obtain advice more locally. C'llr Jill Gibson mentioned that she might know someone that could offer advice, and would try to obtain this. Matter to be placed on March agenda for any necessary further discussion.

**Rosemarket Village issues.** Members noted that the Village was looking very untidy at the moment, especially with the amount of rubbish littering the streets. Members discussed the possibility of paying a handyman to do necessary odd-jobs. C'llr Barbara Summons particularly mentioned issues along the Neyland Road. Clerk to contact P.C.C. regarding the condition of the old railway bridge and damaged stone wall.

**Cycle path.** Members had received complaints about problems with horses on the cycle path. Clerk to write to P.C.C. to ask for the prohibition of horses to be enforced.

#### Any other business

**Cycle path.** C'llr Jill Gibson had noticed the lack of a rubbish bin on the long stretch on Upper Crossing – between Johnston Station and first crossing on Westbury Road. This had led to worse litter and dog mess problems than on other sections of the path.
