Cllr Kidney reported that following the recent Elections and induction of new Councillors, County Hall had been quiet.

2022/05 20 Action Tracking:

- a) Electronic Speed Signs Grant approved by Pembrokeshire County Council The locations have been confirmed and Pembrokeshire County Council are making checks to ensure the requisite services are available
- **b)** Jameston Play Park Enhancing Pembrokeshire Grant Application in process this will be considered by Pembrokeshire County Council in the Autumn
- **c)** Seating overlooking Manorbier Beach –benches have arrived and the slabs will be installed as soon as possible. The Clerk has requested that the contractor makes contact regarding the fixing of the benches.
- **d)** Beavers Hill Crossing safety improvements and possible installation of road safety ramps/signs No further information at present.
- e) Improvements to footpath in Manorbier (Vicarage Fields to Post Office) No further information at present.

The Clerk advised the Council that no Remuneration payments have been made to Councillors during 2021/2022.

2022/05 23 Manorbier Community Hub – To consider a further donation to towards the building of the Community hub

Cllr Kidney proposed that Manorbier Community Council pay a donation of £5,000 towards the building costs of the new Manorbier Community Hub; Cllr Clark seconded the proposal with all Cllrs in full favour.

2022/05 24 The consideration of a footpath in the school/station area to enable safe passage to the school and railway station

Council was advised that concerns have been raised regarding the lack of pavement around the school area. Council acknowledged that this matter had been brought to the Councils attention numerous times in the past. The Clerk to write to Simon Hart requesting assistance in this matter.

2022/05 25 To consider better signage around the school area depicting the speed limits and general road safety and possible speed calming measures put in place.

County Councillor Phil Kidney advised the Council that 20mph signs are scheduled to be erected in the area. Cllr P Kidney will make enquiries as to when the works will be carried out.
